Also in advertisement only 2 years post MTech experience was asked while I had as on closing date of Advertisement total of 8 years experience in the relevant area of Structural Engineering. Also in Advertisement no journal publications were asked for Sr. Scientist, however in shortlisting criteria the same is added. I would also bring to your notice the same, I have journal publications also as filled in my Application. Hence only because the shortlisting criteria is different from that advertised I have lost my chance. Kindly let me know why the shortlisting criteria has been changed from Original Advertisement and in light of this change can the candidate loose out an opportunity, as I had applied for post with interest to join R&D organization.
