- Time for carrying out the work will be 04 (Four) months, and the date of commencement shall be reckoned from the tenth day of issue of award letter.
- A copy of the tender bid submission acknowledgement should be submitted to Office I/C (Civil), Engineering Works & Services Section through a person or by post, before the date and time fixed for opening the tender. CSIR-SERC will not be responsible for any postal delay in any manner. A copy of all documents, submitted online, should be kept (as hard copy) in own custody for reference. **Tenders without Earnest Money Deposit, or without any of the mandatory documents mentioned in check list will be rejected summarily.**

5. The tenderer is to indicate the name and telephone number of issuing agency of the Completion certificate to enable General Technical Evaluation Committee to verify the documents if necessary.
6. In case credentials submitted found to be false/ forged / incomplete / doubtful credential/the offer shall be rejected straightway and shall not be taken for evaluation / comparison purpose. No further clarification will be sought from the tenderers.
7. In case of discrepancy in English and Hindi version, English version prevails.

9. **Work Experience Certificate** : (Refer clause 8(ii) of NIT)
  - i) For work experience, bidders are required to submit Work Experience Certificate (includes completed/ongoing) issued by the employer against the experience of similar completed work containing all the information as furnished in the Work Experience Format.
  - ii) Work order, BOQ, TDS etc. may be sought during clarification or along with deficient documents, if felt necessary by the Works Committee.
10. **Evaluation of Tender:**
  - A. After opening of technical bid, the documents submitted by bidder(s) in cover I as enlisted in the NIT/Bid Document will be downloaded by the Evaluator scrutinized and put up for approval. The Works Committee will examine the uploaded documents against information/declarations furnished by the bidder(s) online / e- procurement portal.
  - B. It is responsibility of Bidders to upload legible/clearly readable scanned copy of all the required documents as mentioned above.

- C. The tender will be evaluated on the basis of documents uploaded by bidder(s) online against the information / declaration furnished in the Bid Submission Confirmation Sheet. The bidder(s) is/are not required to submit hard copy of any document through offline mode. Any document submitted offline will not be given any cognizance in the evaluation of tender.
- D. In case the Committee finds that there is some deficiency in uploaded documents (i.e. w.r.t confirmatory documents) corresponding to the information furnished online/Bid Submission Confirmation .

The shortfall information/ documents should be sought only in case of historical documents which pre-existed at the time of the tender opening and which have not undergone change since then. These should be called only on basis of the recommendations of the TC. So far as the submission of documents is concerned with regard to qualification criteria, after submission of the tender, only related shortfall documents should be asked for and considered.

- E. After Technical evaluation of tender, “Technical Evaluation Summary” will be uploaded by the evaluator and price bid shall be opened as per eprocurement portal. However, date and time of price bid opening, it shall be notified online and price bid shall be opened online on CPP portal after scheduled date and time. In case none of the bidder(s) complies the technical eligibility criteria as per NIT, then bidder(s) will be rejected online and re-tender (if required) will be done (with the same or different quantity, as per the instant requirement).
- F. Financial Bid Evaluation: The financial bids of only responsive eligible bidders will be opened who qualifies as per the technical evaluation criteria of NIT. The price indicated in the financial bid shall be deemed as final. The price quoted by the bidder shall be inclusive of all taxes. The final selection will be based on the price quoted by it in the financial bid.

It may be noted that the tenderer will be selected on the basis of evaluation of Technical and Financial bids by a committee and the committee's decision would be final. The procedure for selection of the party/agency shall be based on Quality & Cost base selection (QCBS) system for evaluation by the committee.

- 11. Technical Specifications: The tenderer shall closely study all specifications in detail, which govern the rates for which he is tendering.
- 12. Handing Over of Site: On completion of the work all rubbish, debris, brick bats etc. shall be removed by the contractor(s) at his/their own expense and the site cleaned and handed over to the company and he/they shall intimate officially of having completed the work as per contract.
- 13. Deployment of Manpower and Machineries: The tenderer(s) will deploy sufficient number and of equipments/machineries/vehicles and the technical/ supervisory personnel required for execution of the work.
- 14. Change in Constitution of the Contracting Agency: Prior approval in writing of the company shall be obtained before any change is made in the constitution of the contracting agency, otherwise it will be treated as a breach of Contract.
- 15. Canvassing in Tender: Canvassing in connection with the tenders in any shape or form is strictly prohibited and tenders submitted by such tenderers who resort to canvassing shall be liable for rejection.

16. Bid Validity: Tender submitted shall remain valid for 90 days from the date of opening for the purpose of acceptance and award of work; validity beyond 90 days from the date of opening shall be by mutual consent.
17. Contract Agreement Document(s):

This Tender Notice shall be deemed to be part of the Contract Agreement. The “General Terms & Conditions”, Additional Terms & Conditions, Special Terms & Conditions (if any), Technical Specifications, drawings (if any) and any other document uploaded on portal as NIT document forms an integral part of this NIT and shall also form a part of the contract agreement as per clause 2 of General Terms and Conditions.
18. Sub-letting of Work:

No subletting of work as a whole by the contractor is permissible. Subletting of work in piece rated jobs is permissible with the prior approval of the department. The total value of subcontracted work should not exceed 25% of the contract price specified in the contract. Procurement of material, hiring of equipment or engagement of labour will not mean sub contracting. If a contractor submits his bid qualifies but does not get the contract because of his being not the lowest, he will be prohibited from working as a sub-contractor for the contractor who is executing the contract. The Contract Agreement will specify major items of supply or services for which the contractor proposes to engage sub-contractor/sub-vendor. The contractor may from time to time propose any addition or deletion from any such list and will submit proposals in this regard to the Engineer-in -Charge/Designated Officer-in-charge for approval well in advance so as not to impede the progress of work. Such approval of the Engineer-in Charge/Designated Officer-in-Charge will not relieve the contractor from any of his obligations, duties and responsibilities under the contract.
19. Prohibition of Child Labour engagement:

The contractor/contractual Agencies must not engage any Child Labour during the course of execution of the contract work within the meaning and scope of the Child Labour Prohibition & Regulation Act-1986 and its relevant Act and Rules amended from time to time by the Govt. of India.
20. Postponement of scheduled date(s): The Company reserves the right to postpone the date of receipt and opening of tenders or to cancel the tenders without assigning any reason whatsoever.
21. The Employer does not bind himself to accept the lowest or any tender and reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.
22. The tenderer shall not be permitted to tender for works in the concerned unit of CSIR in which a relative is posted in the grade between Controller of Administration and Junior Engineer, (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or subsequently employed by him and who relatives are as mentioned above.

**Note:** a person shall be deemed to be a relative of another if, and only if,  
(a) they are members of a Hindu undivided family; or (b) they are husband and wife; or (c) the one is related to the other in the following manner: Father / Mother (including stepmother). Son (including step son), Son’s Wife. Daughter (including Step Daughter), Father, Son’s Son, Son’s Son’s Wife, Son’s, Son’s Daughter’s Husband, Daughter’s husband, Daughter’s Son’s wife, Daughter’s daughter, Daughter’s daughter’s husband, Brother (including step brother), Brother’s wife, Sister (including step sister), Sister’s husband.

23. The Tenderer should see drawings and in case of doubt obtain required particulars, which may in any way influence his tender from the Engineer as no claim whatsoever will be entertained for any alleged ignorance thereof.
24. Before tendering, the tenderer shall inspect the site to fully acquaint himself about the condition in regard to accessibility of site, nature and extent of ground, working condition of site and locality including stacking of materials, installations of tools and plants (T&P) etc., conditions affecting accommodations and movement of labour etc. required for the satisfactory execution of the work contract. No claim whatsoever on such account shall be entertained by the employer in any circumstances.
25. **Earnest money will be forfeited if the contractor fails to commence the work as per Letter of award.**
26. Except writing rates and amount, the tenderer should not upload any conditions or make any changes, additions, alterations and modifications in the tender document. Tenderers who are desirous to offer rebate, the same should be brought separately in the covering letter and submitted along with the tender.
27. Some of the provisions of General Conditions of Contract are given below. Interpretation however shall be as given in the General Conditions of Contract.
  - a) **DEFECTS LIABILITY PERIOD:** Twelve months from the date of completion as certified by the Employer.

Intermediate certificate for lesser amount can be admitted for payment at the discretion of the Engineer-in-charge.

- c) **SECURITY DEPOSIT:** A sum @ 5% of the gross amount of the bill shall be deducted from each running bill of the contractor, This is in addition to the **Performance Guarantee** that the contractor shall be required to deposit an amount equal to **5%** of the tendered and accepted value of the work (without limit) as in the form of BC/DD/ PO/online payment transaction, Bank Guarantee or Fixed Deposit Receipt of a Scheduled bank, with in the prescribed period of ten days for commencement of the work as per award letter issued to him.
- d) **COMPENSATION:** Contractor shall pay as compensation an amount equal to one percent or such smaller amount as the Employer (whose decision in writing shall be final) may decide on the cost of the whole work as shown in the agreement, for every week that the work remains uncommenced or unfinished or due quantity of work remains **incomplete** after the proper dates. Compensation to be paid shall not exceed ten percent of the estimated cost of the work as shown in the agreement.

28. Computerised Measurement books should be submitted by the contractor along with the Request letter, GST Tax Invoice and the bills claimed for making payment.
