
In continuation of CSIR-SERC Notification of even number dated 30-06-2025, notifying the schedule of Stenography test and Computer Proficiency Test (CPT), it is notified for information of all candidates concerned that based on the performance in Stenography test and CPT which was held on 12th and 13th of July, 2025, the Selection Committee has found a total of Twenty two (22) candidates qualified in Stenography test (Annexure I) and One hundred twenty (120) Candidates in CPT (Annexure II) to appear for the Competitive Written Examination (CWE) to be held on **23-07-2025** (Wednesday) in **CSIR - Structural Engineering Research Centre, CSIR Road, Taramani, Chennai – 600113 (Tamilnadu).**

All the candidates who have qualified in Stenography test / CPT are required to report at the Examination Centre by **07:30 AM on 23-07-2025 (Wednesday)** for document verification followed by CWE as follows:



Note:

1. Admit Card for CWE will be made available in CSIR-SERC website shortly.
2. Candidates are required to bring **two Passport Size Photographs** and **Original and two sets** of self-attested Photocopies of the following documents as mentioned for verification on the date of Competitive Written Examination (CWE):
 - i. Hard copy of the Online Application form and Online Fee Payment Receipt.
 - ii. Hard copy of the downloaded Admit card for CWE.
 - iii. 10th / SSC / Matriculation Certificate & Marks sheet
 - iv. 12th / HSC Certificate & Marks sheet
 - v. All other Educational / Technical Qualification (Diploma/ UG / PG) certificates along with marksheets and experience certificates if any.



- vi. Aadhaar Card and one additional Photo ID Proof -PAN Card (Passport will be accepted as proof in lieu of PAN card)
- vii. Community Certificate in GoI format
[Candidates belonging to OBC category are required to bring valid / latest OBC Certificate in GoI format along with the Form of Declaration. *OBC certificate must have been issued before 30.06.2025*]
- viii. No Objection & Vigilance Certificate issued by present employer (if applicable)
- ix. Disability Certificate (if applicable)
- x. In case of widow/divorced women/judicially separated women, relevant certificate/copy of judgement/ decree from the appropriate court of law. Additionally, an affidavit confirming that such candidate has not remarried.
- xi. Copy of Gazette Notification/Affidavit/ Certificate from the appropriate authority in support of change in name/mismatch in name/variation in name of the candidate/parents (if applicable).
3. *Candidate has to produce the Admit card already issued for CPT/Stenography test (held on 12/13.07.2025) containing the signature of the candidate and invigilator to be admitted to appear for the CWE.*
4. Candidates are advised to bring their own stationery items for the test. Black ballpoint pen is essential for answering in OMR sheet.
5. No candidate will be allowed to enter the Exam Hall after the commencement of the examination.
6. Envelopes, mobile phones, digital / smart watches, calculator and any other electronic gadgets are not allowed inside the test hall.
7. Candidates found guilty of using unfair means of any nature shall be liable to disqualification.
8. Silence must be observed inside the test hall at all times.
9. Candidates must abide by further instructions, if any, which may be given to them by the Invigilator. If any candidate fails to do so or indulges in disorderly or improper conduct, he / she will render himself / herself liable to expulsion from the test or such penalty as may deemed fit.
10. All the candidates appearing for Competitive Written Examination (CWE) are advised to make their travel cum accommodation arrangements accordingly. CSIR-SERC will not bear any expenditure in this regard. Outstation candidates are informed to make necessary arrangements to reach Chennai well in advance.
11. Any request for change in date or time of CWE will not be entertained under any circumstances.
12. Candidates are advised to check the CSIR-SERC website www.serc.res.in regularly for all information regarding the examination.
13. The candidature of the candidates in the list is purely provisional and if it is found, at any stage, that he/she has suppressed / misrepresented any information/has submitted false or materially incorrect information or it is found that the candidate does not meet the criteria, his/her candidature will be rejected without any notice even after joining the post.
